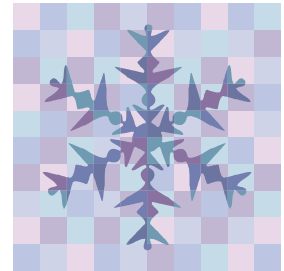


# BOARD BRIEFS
